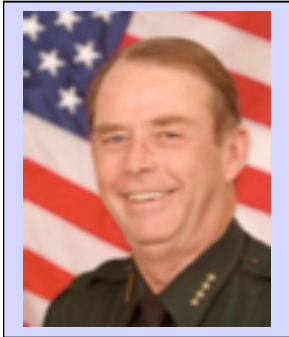
Primary Election Voter Guide

LEON COUNTY SHERIFF

Job Description: In Florida, the County Sheriff is a constitutional officer and is the chief law enforcement officer of the county. Duties include enforcing the Florida Constitution and State Statutes and providing for the security, safety and well being of citizens. This is accomplished through the delivery of law enforcement services, the operation of the County Jail, and the provision of court security.

Salary: Full-time; set by state legislature, funded by county property taxes.
